Privacy Policy

Team Clare Poole ("us", "we", or "our") operates the www.clarepoole.com website (the "service").

This document informs you of our policies regarding the collection, use, and disclosure of personal data when you use our service and the choices you have associated with that data.

We use your data to provide and improve the service. By using the service, you agree to the collection and use of information in accordance with this policy.

Information Collection and Use

We collect several different types of information for various purposes to provide and improve our service to you.

Types of Data Collected

Personal Data

Usage Data

Tracking and Cookies Data

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyse our service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our service.

Examples of cookies we use:

- Session Cookies.
 - o We use session cookies to operate our service.
- Preference Cookies
 - We use preference cookies to remember your preferences and various settings.
- Security Cookies.
 - We use security cookies for security purposes.

Use of Data

Team Clare Poole uses the collected data for various purposes:

- To provide and maintain the service
- To notify you about changes to our service
- To allow you to participate in interactive features of our service when you choose to do so
- To provide customer care and support
- To provide analysis or valuable information so that we can improve the service
- To monitor the usage of the service
- To detect, prevent and address technical issues

Transfer of Data

Unless otherwise stated, your information, including personal data, will be stored and processed in the UK and will be subject to UK data protection laws.

Exceptions to this are:

- Data stored and processed by Wordpress.com (website host)
- Data stored and processed by PayPal

Your consent to this privacy policy followed by your submission of such information represents your agreement to that transfer.

Team Clare Poole will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy. No transfer of your personal data will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information. Should this transfer of data be necessary, express consent will be sought in advance.

Disclosure of Data

Legal Requirements

- To prevent or investigate possible wrongdoing in connection with the service
- To protect the personal safety of users of the service or the public

Security of Data

Your Rights

Time limits for requests to be responded to are 72 hours. The time limit for erasure of data is 30 calendar days.

Service Providers

These third parties have access to your personal data only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.
